<u>Call to Order:</u> The October 11, 2017 meeting of American Legion Post 110 was called to order by Commander David Smith.

Guest Speaker/Special Recognition:

Jennifer Atkinson, an elder care lawyer at the law firm Alperin Law made a presentation about the Veterans Pension Benefit Program.

Commander David Smith presented Adjutant Fred Kinkin with the Legion Membership Excellence medal for his efforts to increase post membership in 2017. Post 110 membership increased from 297 to 366 during the year.

Major Topics Discussed:

- 1. Bert Wendell summarized the results of the Oceana Airshow in September. The post gained 8 contacts for potential membership and raised \$103 for the new post home fund.
