Major Topics Discussed

1. The post Webmaster, Craig Huber, is moving to South Carolina in February. The post has been unable to find a replacement for Craig. One alternative is to have a third party contractor manage the website for the post. It was proposed to have Rawl Gelinas, owner of KeyOps Group, LLC take over managing the website. Rawl was the individual who designed the original website several years ago and current manages the webhosting and domain registration for the site. Rawl has offered his services for \$50/hour (his normal rate is \$100/hour). The continued management of the website is critical to the operation of the post. It is estimated that it takes approximately one hour per month to manage the site. The membership voted unanimously to contract the services of Rawl Gelinas for the next six months with the target cost of \$150 per quarter. In the interim, the post will continue to search for a Webmaster from current membership. Another issue that was discussed is that the current website platform is outdated and potentially could be replaced by a more efficient site that could be easily customized and easily managed which would make finding a Webmaster easier. The membership agreed to receive a proposal to replace the current software.
