Major Topics Discussed

- 1. The Post budget for 2025 was reviewed and approved unanimously by membership.
- 2. Adjutant Fred Kinkin explained the invoicing error made on new 2025 renewal notices which should have stated new 2025 dues are \$45 not \$40. Those members who already submitted their payment with the incorrect invoice will be issued their membership card but will be asked to submit another \$5. New invoices are being issued by National soon.
- 3. A motion was made by Fred Kinkin and seconded by Dave Smith to transfer \$500 from savings to checking in order to ensure expenditures in the next few weeks do not exceed our checking account balance. In three months the \$500 will be transferred back to savings. The motion was approved unanimously.
- 4. Minor changes to the post bylaws were discussed by Adjutant Fred Kinkin. Membership was notified of the proposed changes by email on July 21st. The proposed changes will be voted on by members at the August meeting.
